Thank you for enquiring about our courses. We will be pleased to assist you with training and certification as needed. Our classroom courses are well structured and delivers a more hands-on training within group situations, as like all resuscitation efforts are usually done in practice. Please take note that learning is mostly self-driven, and course preparation by delegates themselves is almost always needed. For AHA's advanced courses (ACLS and PALS), preparation is now mandatory with an online component for both courses that must be completed prior to the course. This online pre-course work is required even for classroom-based advanced courses. The BLS classroom-based course does not have an online part and you can just show up for class then.

You will find the **dates for 2023 on our calendar** that are updated and shared via multiple online platforms. You are welcome to also request an updated version thereof at any time during the year. Please find the registration form attached hereto (booking will only be confirmed with proof of payment and material will not be posted until the application form **and** Proof of Payment have been submitted to training@acls.co.za.) Please include R150.00 should you wish the pre-course materials to be couriered to you (only for physical material, not applicable to online e-books), alternatively it can be collected from our office at Zuid-Afrikaans Hospital Training Centre, Pretoria by appointment and during office hours only. The POCUS course does not have any material distributed before the course date and you can thus ignore the courier fee for this course.

PS: You may also request an e-book instead of a physical book, please specify. Prices remain unchanged as we purchase both physical and online e-books from the relevant company.

Please **provide the preferred dates of the course you wish to attend on the registration form**. We present the courses regularly, and alternate courses between weekdays and weekends to accommodate all different customers. If your preferred dates are fully booked, we can offer alternative dates that might be suitable. You are welcome to enquire about availability before payment.

After we have received the registration form and proof of payment (individuals), we will issue an invoice and receipt that will be sent to you via email. Companies that make group bookings for employees can request us to issue a quote or invoice prior to payment as needed for SARS purposes. We will then also be in contact to arrange for book courier or collection by yourself. We will confirm your booking with an email stating particulars of the specific course, and links or documents for the online pre-course work will be included as applicable. About a week prior to each specific course, we will notify you of logistical arrangements as needed for that course by making a temporary whatsapp group, please look out for an invitation to join the group in case your settings does not allow for group communications. After course attendance and successful completion, we will register your certificates as required and email them to you within a week after course completion. We also register the CPD points with HPCSA as allowed for each specific course (see table below).

BLENDED LEARNING / ONLINE BLS, ACLS & PALS (HeartCode)

The AHA HeartCode courses was initiated during Covid lockdowns and is mostly online learning, after which an individual practical assessment is done by us to ensure competency in the required skills. Please note that this is just a renewal option and if you are doing the course for the first time, you will not be eligible for this way to obtain certification. For the Heartcode courses, there is a complete online component for all courses, including BLS (as there is no classroom lectures). No classroom-based lectures is provided for any Heartcode course certificate and no physical books is distributed.

To qualify for doing the Heartcode versions of the traditional BLS, ACLS and PALS certificates you should be:

1. In **possession of a current and valid certificate of the one you wish to renew** – we will require a copy thereof to register your new certificate now;
2. You should be actively working in the medical sector for which you are registered, and you **should be proficient** in the certificate that you wish to renew.

Please note that the cost of the Heartcode certificates seems less than that of classroom courses on page 1, but the ultimate certification cost remains similar to the traditional classroom course fees. If you add the AHA site course content / e-book fee (payable to AHA) with the final certificate fee (payable to us), the total will be almost similar depending on the dollar-rand exchange rate, import fees etc. The difference is that you will have to purchase the “course content” and e-book directly from AHA when completing the online part (see below \$ charges for their site) , and then we will issue a separate invoice for the practical assessment and the actual final certificate which we purchase for each delegate from AHA. So when doing the Heartcode courses, you will make two separate payments instead of one payment like with the classroom courses.

You must follow the following links and pay the AHA directly for the respective courses after creating an online account with the AHA. If you have an existing account, use the same username and password as always to login. You will need a few hours to complete the online training in the comfort of your home.

The online material is particularly good and well-structured with simulated scenarios and include an electronic copy of ECC Reference book, Textbook and Reference cards.

After completing the above course with the online test, you will then print the certificate and email it to us at training@acls.co.za . At this time you can also provide us with possible dates and times that will suit you to do the final practical assessment. The average time required is 1 hour for BLS and 2 hours for PALS and ACLS each during the individual assessments.
